Location / Dates: 7 May 2020 (Prague, on-line)

Short description: these activities consisted of the presentation of the project activities,

tasks, reporting mechanism, partnership principles and contracts, etc.

7 events (international conferences) have been carried out within this project:

Event 1

Participation: The event involved 87 citizens, including 22 participants from the city of Krakow (Poland), 2 participants from the city of Wroclaw (Poland) 1 participant from the city of Lublin (Poland), 1 participant from the city of Katowice (Poland), 12 participants from the city of Prague (Czech Republic), 5 participants from the city of Vienna (Austria), 1 participant from the city of Tallinn (Estonia), 1 participant from the city of Bratislava (Slovakia). 1 participant from the city of Padua (Italy), 8 participants from the city of Ljubljana (Slovenia), 8 participants from the city of Vilnius (Lithuania) 4 participants from the city of Athens (Greece), 4 participants from the city of Belgrade (Serbia), 3 participants from the city of San Sebastian (Spain), 1 participant from the city of Riga (Latvia), 2 participants from the city of London (UK)

Location / Dates: The event took place in Krakow (Poland) from 08/10/2020 to 09/10/2020 **Short description:** The aim of the event was to discuss the stigmatization and labelling of Muslim migrants in Central European societies and how to ensure equal treatment and opportunities for all in the European Union. Future measures to prevent discrimination were discussed with regard to the national level as well as the EU level.

Event 2

Location / Dates: The event took place in Puchberg (Austria) from 05/11/2020 to 06/11/2020

Short description: The aim of the event was to discuss the legal aid schemes for protection of asylum seekers in Austria and in Central Europe and how to ensure protection of vulnerable refugees.

Event 3

Participation: The event involved 293 citizens, including 199 participants from Greece, 6 participants from Italy, 6 participants from Germany, 14 participants from the Netherlands, 1 participant from Ireland, 2 participants from Turkey, 5 participants from Spain, 5 participants from UK, 8 participants from Austria, 14 participants from Poland, 13 participants from Czech Republic, 13 participants from Lithuania, 11 participants from Slovenia, 3 participants from Hungary, 2 participants from India, 2 participants from Belgium, etc.

Location / Dates: The event took place in the city of Athens (Greece) from 04/03/2021 to 05/03/2021

Short description: The aim of the event was to bring together mayors and local representatives, EU policy makers, civil society and scholars to discuss EU migration policy and policies outside the framework of nation-states, including cities, local governance institutions and civil society organisations.

Event 4

Participation: The event involved 54 citizens, including 39 participants from the city of Prague (Czech Republic), 2 participants from the city of Ljubljana (Slovenia), 3 participants from the city of Athens (Greece), 1 participant from the city of Berlin (Germany), 3 participants from the city of Vilnius (Lithuania) 2 participants from the city of Bratislava (Slovakia), 2 participants from the city of Krakow (Poland), 1 participant from the city of Vienna (Austria), 1 participants from the city of Olomouc (of Polish nationality).

Location / Dates: The event took place in Prague (Czech Republic), from 23/09/2022 to 24/09/2022

Short description: The aim of the event was to explore ways how can and should our EU Member States, cities and civil society organizations contribute to the more just and solidary responses of the European Union towards people seeking protection in Europe.

Event 5

Location / Dates: The event took place in Ljubljana (Slovenia), from 07/10/2021 to 08/10/2021

Short description: The aim of the event was to discuss alternative accommodation options for different social groups (especially the elderly and migrants), present good practices in this field, look for opportunities to develop new solutions in this area and consider the introduction of accommodation models that promote both intergenerational and intercultural solidarity.

Event 6

Participation: The event involved 70 citizens, including 50 participants from Spain, 7 participants from the city of Ljubljana (Slovenia), 2 participants from the city of Prague (Czech Republic), 3 participants from the city of Vilnius (Lithuania), 2 participants from the city of Jonava (Lithuania), 1 participant from the city of Athens (Greece), 3 participants from the city of Krakow (Poland), 2 participants from Italy, 1 participant from the city of Vienna (Austria)

Location / Dates: The event took place in San Sebastian (Spain) from 12/05/2022 to 13/05/2022

Short description: The aim of the event was to discuss the protection of unaccompanied children travelling alone to the EU Member State countries and seek asylum. Different aspects of their arrival, reception and integration were shared between the participants with valuable contributions from the countries of the first arrival of the children i.e. Greece and Spain.

Event 7

Participation: The event involved 46 citizens, including 36 participants from the city of Vilnius (Lithuania), 2 participants from the city of Prague (Czech Republic), 2 participants from the city of San Sebastian (Spain), 1 participant from the city of Vienna (Austria), 1 participant from the city of Athens (Greece), 1 participant from the city of Ljubljana (Slovenia), 1 participant from the city of Kiev (Ukraine), 1 participant from the city of Nur-Sultan (Kazakhstan)

Location / Dates: The event took place in Vilnius (Lithuania), from 15/06/2022 to 16/06/2022

Short description: The aim of the event was to give the opportunity to critically reconsider existing immigration regimes and integration policies in different regions of the EU. Moreover, it aimed to reveal the logic behind the formation of public and political discourses around asylum, immigration and integration processes globally.
